If a Barrier Event has occurred, but the Underlying closes below the Strike Level on the Final Fixing Date, the Investor will still receive the Denomination on the Redemption Date. Otherwise the redemption of the Product will depend on the value of the Underlying, as described in section "Redemption".

In addition, the Product can be early redeemed if the relevant conditions are met on any of the Autocall Observation Dates.
