Product Description

This Product offers the Investor a Coupon Rate regardless of the performance of the Underlying during the lifetime. If no Barrier Event has occurred, the Investor will receive on the Redemption Date a Cash Settlement equal to the Denomination. If a Barrier Event has occurred, but the Underlying closes below the Strike Level on the Final Fixing Date, the Investor will still receive the Denomination on the Redemption Date. Otherwise the redemption of the Product will depend on the value of the Underlying, as described in section "Redemption".

In addition, the Product can be early redeemed if the relevant conditions are met on any of the Autocall Observation Dates.
