Product Description

This Product offers the Investor a Coupon Rate regardless of the performance of the Underlying during lifetime whilst combined with a conditional downside protection. On the Redemption Date the Investor will receive a Cash Settlement equal to the Denomination unless a Barrier Event has occurred. If a Barrier Event has occurred, the redemption of the Product will depend on the value of the Underlying, as described in section "Redemption".

The Issuer has the right for Early Redemption, as further described in "Early Redemption" below.
