This Product offers the Investor a periodic opportunity to receive a Conditional Coupon Amount. If at the Final Fixing Date the Underlying closes at or above the Strike Level, the Investor will receive the Denomination on the Redemption Date. Otherwise, the redemption of the Product will depend on the value of the Underlying, as described in section "Redemption".

The downside risk of this Product is leveraged (Downside Participation), if the Final Fixing Level of the Underlying is below its Strike Level.
