If a Knock-Out Event, as defined below, has occurred, the Product expires worthless immediately. The Call Warrant with Knock-Out Open End does not have a fixed maturity (open end), but may be exercised by the Investor or terminated by the Issuer. The Current Knock-Out Barrier is always equal to the Current Strike.
